I am aware that the Bank shall not be liable for the loss or other expenses of the Client or third parties, which may arise due to the delay in issuing the code calculator (Digipass) and/or Card, its loss, damage or misuse, including disclosure of confidential information or other circumstances beyond the control of the Bank;
